Foundation Receives \$100,000 in Planning Grants from the Lilly Endowment, Inc.

The Western Indiana Community Foundation has received two \$50,000 planning grants as part of the eighth phase of Lilly Endowment Inc.'s initiative, Giving Indiana Funds for Tomorrow (GIFT VIII). The first grant is for the Fountain County Parks Assessment. The Community Foundation has engaged with the consulting firm of Kimley-Horn to evaluate the quality of existing parks and facilities within Fountain County based on existing conditions including, but not limited to park infrastructure, amenities, and buildings. These grant dollars will be used to further enhance the efforts to create a better quality of life for our local communities through parks and recreation.







Secondly, the Western Indiana Community Foundation has partnered with the Warren County and Vermillion County Community Foundations to develop the Wabash River Blueway Master Plan. Fountain, Vermillion, and Warren counties have 74 miles of the Wabash River forming their borders. The river has untapped potential for recreation, historical and scientific education, the arts, and attracting visitors.

The Western Indiana Community Foundation is one of 92 community foundations and affiliate funds in Indiana receiving planning grants through GIFT VIII. These grants are designed to help community foundations collaborate with local partners to engage broad and diverse stakeholders in their communities and deepen their understanding of their communities' highest-priority challenges and opportunities. In 2024, the

Western Indiana Community Foundation will have the opportunity to request funding to implement strategic initiatives and activities developed during the planning period that address especially compelling needs in Fountain County.

Lilly Endowment created the GIFT initiative in 1990 to help local communities in Indiana develop the philanthropic capacity to identify local needs and challenges and work with other organizations to help their communities thrive. Through GIFT VIII, Lilly Endowment has allocated up to \$210 million to support Indiana's community foundations in growing their financial resources and further strengthening their ability to address their community's highest-priority challenges and opportunities.

New Funds

The endowment funds listed below have recently been established by local organizations, businesses, and/or caring citizens. Any individual, business, or organization can establish a fund and/or contribute to an existing fund at any time.

Donations made to these endowment funds are invested and a portion of the earnings is used to award grants to community organizations and/or to award scholarships to students for their post-high school education. Donations can be made in a variety of forms including gifts of cash, stock, real estate, life insurance, and charitable bequests.

Endowment funds can be established in honor or memory of loved ones for as little as \$1,000. Payouts ("distributions") from endowment funds begin when the fund has reached \$10,000 in cumulative donations and has been invested for one full calendar year.

Here is a listing of the most recent endowment funds established though the Western Indiana Community Foundation.

Marilyn's Village Fund

This recently established fund is designed to offer assistance for initiatives related to Marilyn's Village, a program dedicated to empowering adults with disabilities by facilitating their active engagement and contributions to the community. Situated near Covington's town square, Marilyn's Village is committed to supporting individuals with disabilities, their families, and the community at large. Initially, the program will provide day habilitation and pre-vocational programs tailored for adults with disabilities. Furthermore, Marilyn's Village will operate a café accessible to the community throughout the week.





Marilyn Sowers, known as "Gmama Sowers," dedicated her life to serving her community, actively seeking

out individuals to care for and love. She had a deep passion for working with people, particularly those with disabilities. Marilyn was involved in various activities, such as working in special education classrooms, ensuring the well-being of disabled neighbors, and volunteering with Special Olympics. Marilyn's Village aims to mirror her compassionate care for adults with disabilities and provide a meaningful purpose for many individuals.

With a long-term horizon, the Foundation investment philosophy prioritizes the preservation of the original donor gift. Donations are invested (with the exception of pass-through funds) in order to create an annual stream of income which is distributed to the charitable organizations, scholarship recipients or the purpose as designated by the donor.

A large number of endowed funds that donors created with the Foundation are given as unrestricted grants, which means the Foundation has the discretion to grant those annual earnings to meet the community needs in the areas designated by the donor. We call these funds Unrestricted Funds or Community Funds. The Foundation holds more than 45 of these funds (of our total of 350 funds). Earnings of more than \$475,000 are available to be distributed Ifrom these 45 funds annually.

Grant Guidelines

Grant Focus

Western Indiana Community Foundation focuses on local needs within the geographical boundaries of Fountain County with consideration given to the areas of health, charitable service, education, cultural affairs, and community improvement.

All endowment funds, which stipulate in the fund agreement the areas to be supported from the income earned on the fund assets, will be honored regardless of location of the grant recipient.

Grant Review

The Board of Directors will review each grant request in preparation for its regular board meeting. Grant applications may be submitted at any time throughout the year. Applicants will be notified immediately following the Board of Directors' decision.

The Western Indiana Community Foundation is especially interested in learning of plans for:

Startup costs for new programs

· Capital needs beyond an applicant's capabilities

· One time projects or needs

The Western Indiana Community Foundation will not consider:

- Individuals except for scholarships
- Support for regular operating budgets
- · Long-term funding
- Apparel such as school/sport uniforms
- Organizations for political or religious purposes
- · Contributions to endowments
- · Post-event situations

How to Include the Attica, Covington, or Southeast Fountain Community Foundation in Your Will

How you include a charity in your will depends on what sort of gift you would like to make, and how you want to provide for your other beneficiaries. Take a look at the examples below.

1) Make a specific bequest

This bequest is an exact description of a dollar amount or specific asset from your estate to go to a beneficiary. It is very important that specific bequests be exact – vagueness can lead to confusion. Keep in mind that specific bequests are usually the first to be paid out.

When Conrad made his will, he left his collection of fine art to his nephew and \$50,000 to the Community Foundation.

(2) Make a percentage bequest

This bequest designates a fraction of the available estate to a beneficiary. Many prefer this kind of bequest because the relative size of the bequest is tied to the value of the estate, and that treats all heirs equally.

When Evelyn made her will, she left 25% of her estate to each of her twin daughters (50%), 25% to her local city park, and 12.5% each to her church and the Community Foundation.

(3) Make a residual bequest

This bequest assigns all the property that remains after the payment of administration costs, taxes and expenses, and every other bequest has been satisfied. A simple way to describe the residue of an estate is that which is "left over." After you have made provisions for individuals with exact amounts, you can give whatever is left of your estate to a worthy charity such as the Community Foundation. This option assures that your heirs are taken care of first.

When Marilyn made her will, she left \$150,000 to each of her four children (\$600,000), \$50,000 to a good friend Thomas, and whatever was left of her estate to the Community Foundation.

4 Make a contingent bequest

This bequest puts in place a "back-up" beneficiary – an individual or organization who will receive the gift only under certain circumstances. This option assures that unintended persons do not receive a gift originally meant for someone else.

When Daniel made his will, he left his entire estate to his wife, Paula. In the event she precedes his death, his estate will be divided between the Community Foundation and two other worthwhile charities.

Note: When leaving a bequest to the Community Foundation through your will, your attorney will want to know our Tax I.D. #: 35-1814927

Types of Funds at the Community Foundation

Each fund type allows a community, donor, or nonprofit to accomplish its goals. See which fund type best fits your charitable intentions.

Unrestricted Funds

Unrestricted Funds give community members a way to support basic needs and enhance the quality of life in their hometown. You make a gift to the Community Foundation with no suggestion or preference as to which organization the grants are to be made. These are the largest grant-making funds at each of the Community Foundations. Grants are made from these funds to support worthwhile projects, programs, and nonprofit organizations within each Foundation's geographic territory.

Field of Interest Funds

Field of Interest Funds are similar to Unrestricted Funds, except the individual has specified an area (history, education, arts, etc.) in which grants will be given..

Designated Funds

Designated Funds support one or more specific charitable organizations selected by an individual when they create a new fund and benefit specific charitable organizations by the donor. With a Designated Fund, you can support organizations that are important to you for generations.

Scholarship Funds

Scholarship Funds benefit Fountain County students pursuing higher education. As a scholarship fund holder, you will set the focus of the scholarship and application parameters. WICF will handle all the paperwork necessary to comply with federal regulations and issue scholarship checks.

Agency Endowment Funds

Agency Endowment Funds are a form of Designated Fund that benefits only one specific organization. These funds allow nonprofit agencies the ability to build a continual and dependable stream of future income to support their operations. They also provide a long-term funding source for nonprofit organizations that create them.

Scholarship News

Western Indiana Community Foundation is pleased to announce that the Foundation will help to distribute \$450,000 in scholarships to approximately 175 students this year.

The Foundation distributes support from over 115 different scholarship funds. This year, awards ranged from \$500 up to full tuition and fees.

No two scholarships are alike, and each scholarship has its own distinct criteria as determined by the founding donor such as financial need, community/volunteer service, special interest/intended study, or GPA requirements. Education criteria vary, as well, and most scholarships target graduating seniors, while some are available to students currently enrolled in college.
