



## DATES TO REMEMBER

## 2024

**JULY 1 –** Scholarship recipients can begin requesting payment through the portal on our website.

**JULY 1 –** The online application process for the Lilly Endowment Community Scholarship begins. This scholarship provides full tuition, plus a \$900 book and fee stipend, to any Indiana public college or university. For details go to: **www.wicf-inc.org**.

**SEPTEMBER 1 –** Deadline to complete the online Lilly Endowment Community Scholarship application.

**SEPTEMBER 1** – Deadline for verification of school information for fall semester scholarship payments. Students must contact the Foundation office if this deadline cannot be met.

NOVEMBER 12-18 – Community Foundation Week, created in 1989 by former President George H.W. Bush, recognizes the important work of community foundations throughout America and their collaborative and innovative approach to working with the public, private, and nonprofit sector. Community Foundation Week coincides with National Philanthropy Day on November 15.

**DECEMBER 3** – Giving Tuesday, often stylized as #GivingTuesday for purposes of hashtag activism, refers to the Tuesday after U.S. Thanksgiving in the United States. It is a movement to create a national day of giving at the beginning of the Christmas and holiday season. Giving Tuesday was started in 2012 as a response to commercialization and consumerism in the post-Thanksgiving season (Black Friday and Cyber Monday).

**DECEMBER 31** – Last day for scholarship recipients to request their second payment (if applicable).

DECEMBER 31 - Last day to make year-end gifts for 2024 tax purposes. Start planning NOW!

MARCH 1 – Deadline for all Foundation scholarships.

## **GRANT GUIDELINES**

### **GRANT FOCUS**

Vermillion County Community Foundation focuses on local needs within the geographical boundaries of Vermillion County with consideration given to the areas of health, charitable service, education, cultural affairs, and community improvement.

All endowment funds, which stipulate in the fund agreement the areas to be supported from the income earned on the fund assets, will be honored regardless of location of the grant recipient.

#### **GRANT REVIEW**

The Board of Directors will review each grant request in preparation for its regular board meeting. Grant applications may be submitted at any time throughout the year. Applicants will be notified immediately following the Board of Directors' decision.

The Vermillion County Community Foundation is especially interested in learning of plans for:

- Start-up costs for new programs
- One-time projects or needs
- Capital needs beyond an applicant's capabilities

## The Vermillion County Community Foundation will not consider:

- Individuals, except for scholarships
- Organizations for political or religious purposes
- Support for regular operating budgets
- Contributions to endowments
- Long-term funding
- Post-event situations
- Apparel such as school/sport uniforms

# **NEW FUNDS**

The endowment funds listed below have recently been established by local organizations, businesses, and/or caring citizens. Any individual, business, or organization can establish a fund and/or contribute to an existing fund at any time.

Donations made to these endowment funds are invested and a portion of the earnings is used to award grants to community organizations and/or to award scholarships to students for their post-high school education. Donations can be made in a variety of forms including gifts of cash, stock, real estate, life insurance, and charitable bequests.

Endowment funds can be established in honor or memory of loved ones for as little as \$1,000. Payouts ("distributions") from endowment funds begin when the fund has reached \$10,000 in cumulative donations and has been invested for one full calendar year.

Here is a listing of the most recent endowment funds established though the *Vermillion County Community Foundation*.



# DR. WILLIAM SOMERVILLE SCHOLARSHIP FUND

The Dr. William Somerville Scholarship Fund has been created to support local high school seniors graduating from a Wabash River Conference High School who aspire to pursue an education or profession in the fields of animal care and/or veterinary medicine.

Dr. Somerville began his educational journey by graduating from Clinton High School in 1969, then earning his Bachelor of Science degree from Indiana University in 1973. Following that, he pursued his passion for veterinary medicine, obtaining a Doctor of Veterinary Medicine from Purdue University

in 1979. With 37 years of dedicated practice in veterinary medicine, he spent 33 years as the proud owner of a veterinary practice he established from the ground up.





With a long-term horizon, the Foundation investment philosophy prioritizes the preservation of the original donor gift. Donations are invested (with the exception of pass-through funds) in order to create an annual stream of income which is distributed to the charitable organizations, scholarship recipients or the purpose as designated by the donor.

A large number of endowed funds that donors create with the Foundation are given as unrestricted grants, which means the Foundation has the discretion to grant those annual earnings to meet the community needs in the areas designated by the donor. We call these funds Unrestricted Funds or Community Funds. The Foundation holds eight of these funds (of our total of 88 funds). Earnings of nearly \$100,000 are available to be distributed from these eight funds annually.

# FOUNDATION RECEIVES \$100,000 IN PLANNING GRANTS FROM THE LILLY ENDOWMENT, INC.

The Vermillion County Community Foundation has received two \$50,000 planning grants as part of the eighth phase of Lilly Endowment Inc.'s initiative, Giving Indiana Funds for Tomorrow (GIFT VIII). The first grant is for the Childcare Needs Assessment at the former Ernie Pyle Elementary School. The Community Foundation has engaged with the consulting firm of RJL Solutions to learn more about the need for additional childcare resources, which could be utilized in the former Ernie Pyle Elementary School. These resources could include, but are not limited to, before- and after-school care, early learning initiatives, and more.







Secondly, the Vermillion County Community Foundation has partnered with the Warren County and Western Indiana Community Foundations to develop the Wabash River Blueway Master Plan. Fountain, Vermillion, and Warren counties have 74 miles of the Wabash River forming their borders. The river has untapped potential for recreation, historical and scientific education, the arts, and attracting visitors.

The Vermillion County Community Foundation is one of 92 community foundations and affiliate funds in Indiana receiving planning grants through GIFT VIII. These grants are designed to help community foundations collaborate with local partners to engage broad and diverse stakeholders in their communities and deepen their understanding of their communities' highest-priority challenges and opportunities. In 2024, the Vermillion County Community Foundation will have the opportunity to request funding to implement strategic initiatives and activities developed during the planning period that address especially compelling needs in Vermillion County.

Lilly Endowment created the GIFT initiative in 1990 to help local communities in Indiana develop the philanthropic capacity to identify local needs and challenges and work with other organizations to help their communities thrive. Through GIFT VIII, Lilly Endowment has allocated up to \$210 million to support Indiana's community foundations in growing their financial resources and further strengthening their ability to address their community's highest-priority challenges and opportunities.

# **How to Include the Vermillion County Community Foundation in Your Will**

How you include a charity in your will depend on what sort of gift you would like to make, and how you want to provide for your other beneficiaries. Take a look at the examples below.

## MAKE A SPECIFIC BEQUEST

This bequest is an exact description of a dollar amount or specific asset from your estate to go to a beneficiary. It is very important that specific bequests be exact – vagueness can lead to confusion. Keep in mind that specific bequests are usually the first to be paid out.

When Conrad made his will, he left his collection of fine art to his nephew and \$50,000 to the Community Foundation.

## MAKE A PERCENTAGE BEQUEST

This bequest designates a fraction of the available estate to a beneficiary. Many prefer this kind of bequest because the relative size of the bequest is tied to the value of the estate, and that treats all heirs equally.

When Evelyn made her will, she left 25% of her estate to each of her twin daughters (50%), 25% to her local city park, and 12.5% each to her church and the Community Foundation.

## MAKE A RESIDUAL BEQUEST

This bequest assigns all the property that remains after the payment of administration costs, taxes and expenses, and every other bequest has been satisfied. A simple way to describe the residue of an estate is that which is "left over." After you have made provisions for individuals with exact amounts, you can give whatever is left of your estate to a worthy charity such as the Community Foundation. This option assures that your heirs are taken care of first.

When Marilyn made her will, she left \$150,000 to each of her four children (\$600,000), \$50,000 to a good friend Thomas, and whatever was left of her estate to the Community Foundation.

# MAKE A CONTINGENT BEQUEST

This bequest puts in place a "back-up" beneficiary an individual or organization who will receive the gift only under certain circumstances. This option assures that unintended persons do not receive a gift originally meant for someone else.

When Daniel made his will, he left his entire estate to his wife, Paula. In the event she precedes his death, his estate will be divided between the Community Foundation and two other worthwhile charities.

## TYPES OF FUNDS AT THE COMMUNITY FOUNDATION

Each fund type allows a community, donor, or nonprofit to accomplish its goals. See which fund type best fits your charitable intentions.

- ▶ Unrestricted Funds Unrestricted Funds give community members a way to support basic needs and enhance the quality of life in their hometown. You make a gift to the Community Foundation with no suggestion or preference as to which organization the grants are to be made. These are the largest grant-making funds at each of the Community Foundations. Grants are made from these funds to support worthwhile projects, programs, and nonprofit organizations within each Foundation's geographic territory.
- Field of Interest Funds Field of Interest Funds are similar to Unrestricted Funds, except the individual has specified an area (history, education, arts, etc.) in which grants will be given.
- ▶ Advised Funds Provides individuals or organizations an opportunity for continuing involvement in the annual distribution from their funds.
- Designated Funds Designated Funds support one or more specific charitable organizations selected by an individual when they create a new fund and benefit specific charitable organizations by the donor. With a Designated Fund, you can support organizations that have been important to you for generations.
- ▶ Scholarship Funds Scholarship Funds benefit Vermillion County students pursuing higher education. As a scholarship fund holder, you will set the focus of the scholarship and application parameters. WICF will handle all the paperwork necessary to comply with federal regulations and issue scholarship checks.
- ▶ Agency Endowment Funds Agency Endowment Funds are a form of Designated Funds that benefit only one specific organization. These funds allow nonprofit agencies the ability to build a continual and dependable stream of future income to support their operations. They also provide a long-term funding source for nonprofit organizations that create them.
